2. Correspondence In

An email was received from Rosas Brogan announcing his retirement from Charles Sturt University.

An email was received from Mr. Grantley Douglass, asking someone from the NSWAFI to contact him by telephone. This was done by Bob McKay. On speaking to Mr. Douglass, it became clear that Mr. Douglass had been in contact with the NSWAFI previously regarding an incident over ten years ago, when an illicit chemical storage facility at Wilberforce burnt down. This facility was owned and operated by Mr. Douglass. Apparently, as a result of the fire, Mr. Douglass was charged with various offences. On this occasion, Mr. Douglass wanted the NSWAFI to investigate the fire. When Mr. Douglass was told the NSWAFI was an association, with the focus on education, Mr. Douglass became abusive. The telephone call was terminated by Bob McKay. This telephone call was reported to Michael Forbes.

4. President's Report

Michael Forbes reported that the IAAI Vehicle Fire Course (MVFI) went well. Michael said that he has only received positive feedback, which was good. Expenses for the course were \$2,327.69, but we were still awaiting another two invoices, which should be another \$1,500.00 which could bring it up to a loss of about \$4,000.00. Michael said he would prepare a report on the MVFI for the other AAFI Presidents. Michael raised the possibility of one of the other associations hosting a MVFI in the future. Michael said he was surprised over the number of out of State students. Michael said that in 2020 we should consider running a course on truck fires. Bob McKay said that Rusty Colosi, from Canada, would be keen to come to Australia in October, 2020, but that would clash with the 2020 AAFI.

Michael suggested we, with the assistance of the IAAI conduct an Expert Witness Course (EWC) in 2020. Michael said it was suggested by IAAI that NSWAFI get a lawyer or a prosecutor for the course. Michael said he would approach a prosecutor he knows at the Coroners Court and see if we can use the Coroners Court as a venue, because a Court is needed, for the student to do a presentation and be cross examined. Michael said the when the IAAI ran the EWC Course in South Africa, they got a lawyer and a judge and amended the course as it went along. At the end of the South African course, with the amendments, they had a course to meet South African requirements. Michael also stated that there would be maximum of 10 students and suggested a course fee of \$500.00 USD for members.

Michael also reported that the AAFI Memorandum of Understanding (MOU) has now been signed by all members of the AAFI. Apart from this, Michael reported that seed funding had been transferred from VAFI to New Zealand for the 2020 AAFI Conference.
