## Correspondence.

#### President's Report.

Michael Forbes reported that the past 12 months went well, as did the Education Nights and our first Social Event at the end of 2018. Michael said we had the AAFI in Victoria last year and one Scholarship was awarded for attendance at the AAFI.

Michael said the Association is good financially speaking and we have some more training coming up and that the Association is about to lock in a motor vehicle fire investigation course through the IAAI for the 22 to 24 October, 2019. This will involve two IAAI instructors coming to Australia. They will teach the course and do some live burns. Michael said there is a maximum of 30 students and that this is the first time the course has been done outside the U.S. Michael said on successful completion students can apply for the motor vehicle specialist credential endorsement.

There was a question from the floor about cost. Michael said that the IAAI were hosting the course so students would need to enrol through the IAAI web site and pay in U.S. Dollars. Alternatively, NSWAFI can host and pay IAAI. The NSWAFI do need to supply vehicles and take care of site and suppression costs. Michael said that the Academy will be used for the class room work and the burns will happen at Londonderry. Michael said that he estimates the

cost of the vehicles at about \$1,500.00 but asked if there are any members that can get donated vehicles that would be good, but we need the glass intact. Joe Zaouk said he believes he can get vehicles.

Membership is now at about 155 members which is a slight growth in membership over last year. Michael also reported the Facebook site is going with over 700 likes.

Michael said we are still having another two Education Nights and that Sonia and Vicky are organising the Social Night in December. Finally, Michael reminded everyone that next years AAFI Conference is in New Zealand.
