4. President's Report

Michael Forbes said that whilst a loss was not ideal, but the NSWAFI had sufficient funds to cover the loss, and there is an anticipation that the forthcoming EWTC would generate more income.

Mark Pellegrino wanted to know how he should pay his IAAI Membership and what evidence the Treasurer required for a refund. Taylor Pallaton suggested a snap shop of the part of Mark's Bank Statement showing the amount paid.

Michael Forbes said that he has been speaking with Rick Jones about if and when an EWTC could be run in Australia and how it was going to be run. Michael said that Rick Jones told him that he, Rick Jones, went to South Africa and ran a EWTC on the fly and established a South African syllabus as the course was delivered. Rick Jones said that all IAAI course must be delivered by a Certified Instructor (CI) and that if Michael Forbes went through the course, Rick Jones would sign Michael Forbes off as a CI, so that NSWAFI could run EWTC in the future. Michael told Rick Jones that we may have enough people to run two EWTC. Rick said that would be

perfect as he would run the first EWTC. Then Michael Forbes would run the second EWTC. Rick Jones said that the IAAI would fund the first course and then NSWAFI would fund the second EWTC and obtain any profit from the second EWTC.

Michael said there was a lot of discussion as to when the EWTC would be run. Michael said the spoke to Steve Kelly, an Advocate Sergeant at the Coroner's Court and he was supportive of the EWTC being run at the Coroner's Court and would provide two Advocates to put the Australian content. Rick Jones said that he was going to attend the AAFI and suggested that the EWTC be run the week before the AAFI, which would allow Rick jones to come to Australia, run the EWTC and then continue to New Zealand for the AAFI. Michael Forbes said the had been able to book the Coroner's Court for five days.

Michael Forbes said to gage numbers for the EWTC an email was sent to all members and the other Associations. This email prompted Greg Kelly to respond, indicating he was concerned with the way the CI would be selected and wanted a Committee, made up of members of each of the AAFI member associations to call for nominations from people wanting to be CI and the Committee would select the best person to be trained as a CI. Michael said he disagreed with this suggestion as it would take too long.

Bob McKay point out that if a Committee was established to 'vet and select' CI candidates, the person/s selected would still need to meet IAAI CI suitability requirements, which Bob believes is putting another selection process in place, when it is not required. Bob also pointed out that NSWAFI is a Chapter of IAAI and the NSWAFI is bound by IAAI rules and regulations.

Steve Apps said that he would support Michael Forbes being made CI as he believes that to have a second committee selecting CI candidates would take too long and the EWTC would drown in bureaucracy.

Bob McKay said that the important thing is that we (NSWAFI) need Cl's in Australia because we currently do not have any Cl's. Sonia Scott asked if the proposal by Michael Forbes and Rick Jones would prevent anyone in the future from become a Cl. Michael said it would not.

11. New Business

Michael wanted to know if everyone was happy for the NSWAFI to book two spots at the AAFI for the Ross Brogan Scholarship. If all happy, Michael would pay for the two registrations from his own pocket and seek reimbursement later.

Ross Brogan Scholarship Application was from Steve Apps

It has been raised by Alex Visotin and Taylor Pallaton that the qualifying period of 10 years for sub-committee member be reduced to possibly five (5) years. This has been fixed on the web site and no further action is

required.

As Michael Forbes has been invited by the AAFI Organising Committee to present at the AAFI 2020 Conference, which includes conference registration, Michael wants the Committee to consider the cost of Michaels registration, which the Committee agreed to fund, be diverted into a second Ross Brogan Scholarship for 2020.

Steve Apps has asked the Committee to consider reducing Education Nights to four (4) per year. There was a discussion about the number of Education Night run each year and whether or not the number should be reduced. Michael Forbes said that it any Education Night were to be dropped, he would prefer the February Education night be dropped. If the number was to be dropped to four education nights, then the other to go would have to be December.

Bob McKay reported that he has been invited to speak on heavy vehicle fires at the AAFI 2020 Conference.
